ALTERATIONS/ADDITIONS: minor although porch enclosure may not be original

ARCHITECTURAL STYLE/TYPE AND SIGNIFICANCE: Good example of basic four-square house with variety of details; most closely tied to Prairie style.

SIGNIFICANT PERSONS AND EVENTS ASSOCIATED WITH SITE: Built circa 1920.

RELATIONSHIP TO SURROUNDINGS: One of few relatively intact residential buildings in immediate area.
